Mimi Abramovitz, MSW, DSW (Columbia) is The Bertha Capen Reynolds Professor of Social Policy at Hunter School of Social Work and The CUNY Graduate Center. She is author of *Regulating the Lives of Women: Social Welfare Policy From Colonial Times to the Present*, the award-winning *Under Attack, Fighting Back: Women and Welfare in the US* and co-author of *Taxes Are A Women's Issue: Reframing the Debate*. A scholar/activist and recipient of numerous awards from major professional associations, Dr Abramovitz is frequently interviewed by the print and broadcast media and regularly invited to keynote national and international meetings.

Mimi Ajzenstadt is Lionel Cohen Senior Lecturer in Law, a Professor at the Baerwald School of Social Work and Social Welfare and at the Institute of Criminology, Faculty of Law, and the Chair of the Later Center for Gender Studies at the Hebrew University of Jerusalem. Her research interests lie in the areas of sociology of law and in the areas of gender, social policy and the welfare state. She has examined the development of social policy towards women in the Israeli welfare state. Currently, she is researching the societal reaction to crime committed by legal and illegal migrants in Israel.

Felice Batlan is a professor at Chicago-Kent College of Law. She holds a JD from Harvard Law School, a doctorate in US history from New York University, and specializes in feminist jurisprudence and women's legal history. She has written extensively on the gendered origins of public interest law and the role that women played as legal activists and lay lawyers in the late nineteenth century. Before entering the academy, she practised law for nine years.

Dorothy E Chunn, MA, PhD (Toronto), is Professor of Sociology and Co-Director of the Feminist Institute for Studies on Law and Society at Simon Fraser University. Her recent research and publications focus on poor women's perceptions and experiences of welfare reform; feminism, law and social change since the 1960s; and the politics of Canadian custody law reform. She is co-editor (with Susan B Boyd and Hester Lessard) of *Reaction and Resistance: Feminism, Law, and Social Change* (University of British Columbia Press, 2007).

Shelley AM Gavigan, BA, LLB (Sask), MA (Toronto), LLM (Osgoode/York), SJD (Toronto) is a Professor of Law at Osgoode Hall Law School in Toronto, Canada, and a member of the Bars of Saskatchewan and Ontario. Her research interests focus on socio-legal theory and history in the areas of Canadian criminal law; law and poverty; legal regulation and definition of family; access to justice and social justice.

Joan M Gilmour, BA, LLB (Toronto), JSM, JSD (Stanford), is an Associate Professor at Osgoode Hall Law School in Toronto, Canada, and a member of the Bar of Ontario and British Columbia. She is Director of Osgoode's Master's programme specializing in Health Law, and has served as a consultant to Health Canada and the Ontario Law Reform Commission. Her research spans a range of issues, including the interrelation of disability, gender, inequality and law, the effects of the tort system on patient safety, and health system restructuring.

Hester Lessard is a Professor at the University of Victoria Faculty of Law in Victoria, BC Canada. The following general areas are the focus of her teaching and research: feminist legal theory, human rights law, social movements and law, and Canadian constitutional rights jurisprudence. She is co-editor (with Susan B Boyd and Dorothy E Chunn) of *Reaction and Resistance: Feminism, Law, and Social Change* (University of British Columbia Press, 2007).

Janet Mosher is an Associate Professor of Law and Associate Dean at Osgoode Hall Law School, York University, in Toronto, Canada. Her research has focused on legal interventions that impact upon women abused in their intimate relationships, and she is currently engaged in a research project exploring the multiple ways in which state policies and practices are implicated in sustaining woman abuse. She has also published on poverty law, access to justice for disadvantaged groups, legal aid and legal ethics. She is currently the English language editor of the *Canadian Journal of Women and the Law*.

Premilla Nadasen is an Associate Professor of History at Queens College, CUNY. She writes and speaks about social policy and activism. She is author of *Welfare Warriors: The Welfare Rights Movement in the United States* (winner of the John Hope Franklin Prize) and is currently working on a book about domestic worker organizing.

Karen Swift holds a doctorate in Social Work and is a Professor in the School of Social Work, York University. She is the author of numerous publications on issues of gender and social policy, including *Manufacturing 'Bad Mothers': A Critical Perspective on Child Neglect* (1995). She is also

the co-author of a social policy text, called *Canadian Social Policy: An Introduction*, which is in its third edition (2008). Her latest book is *At Risk: Social Justice in Child Welfare and Other Human Services*, co-authored with Marilyn Callahan, and will be published by University of Toronto Press in autumn 2009.

Margot Young is Associate Professor of Law at the Faculty of Law, University of British Columbia. She researches and teaches in the areas of constitutional law and social justice. She is co-editor of *Poverty: Rights, Social Citizenship and Legal Activism* (University of British Columbia Press, 2008). She has worked for some years with women's equality-seeking groups on NGO submissions to United Nations committees documenting Canada's failures to observe international human rights obligations. She is a Research Associate with the Canadian Centre for Policy Alternatives, BC Office.
