### Hong Kong laws and expert interpretations

Legal provisions have different versions - currently effective, invalid, and gazetted but ineffective - to facilitate comparison. ### Case analysis

It has collected more than 700 typical and widely-discussed cases related to Hong Kong and other common law systems from 2008 to 2022. Case analysis was conducted by Hong Kong's prestigious barrister teams. In addition to important cases in Hong Kong, it also includes offshore cases related to Cayman Islands, British Virgin Islands and Bermuda. Annotated cases include the full text of judgment documents, keywords, cited or applicable cases and laws, and case relationship diagrams.
