Martina Timmermann is the Director of Studies on Human Rights and Ethics at the United Nations University in Tokyo. She is also the Academic Programme Officer for the Peace and Governance Programme at the United Nations University. Previously, she was assistant professor in the Department for International Relations/Foreign Policy at Trier University, Germany. From 2000 to 2004, she was the head of a DFG-funded research project, "The human rights politics of Japan, Malaysia, Thailand, Indonesia and the Philippines: Mirror of 'Asian' Identity?" conducted at the Institute of Asian Affairs in Hamburg. Her fields of research include: human rights and ethics in international relations; business and human rights; globalisation and regionalisation; Japanese/German foreign policy. She is a political scientist and has published on women's rights, child rights, especially the issue of the commercial sexual exploitation of children. She is presently working on "The UN Global Compact: The role of SMEs (Small and Medium Enterprises) for reaching the Millennium Development Goals (MDGs)".

Amanda Whiting is a Lecturer in the Faculty of Law and Associate Director (Malaysia) in the Asian Law Centre. She is currently involved in teaching in the undergraduate LL.B program. Previously co-editor of the *Australian Journal of Asian Law* in 2002, she completed her honours degree in Arts at the University of Melbourne in 1981 and then taught 17th and 18th century history at the University's History Department over the next decade.
